PUBLIC COMMENT

First call for public comment.

- Resident 1 is opposed to the location due to the smell of cannabis being a trigger for migraines.
- By having the store in the mall, it will limit her ability to access the mall.
- Staff read aloud three additional letters received from the China Moon Restaurant, Crossroads Cannabis, and Burns Lake Band.

- Staff informed attendees of the next steps. A report will go to Council on the March 3 Regular Meeting.
- Council asked T. Robinson from Mojo Cannabis to speak to some of the concerns that were received.
- T. Robinson addressed the concern of being an 'out-of-town' enterprise. Mojo will have a number of locations across the province. The plan is to hire ten employees for the Burns Lake location, and they want to hire locally.
- They will have security measures, and the mall has security. Mojo promotes the safe consumption of cannabis.
- Retail stores do not smell, as the cannabis is prepackaged for sale from the government. They will have smell jars for consumers to smell the product.
