BYLAW NO 1014, 2020**

**A Bylaw to Establish Fees and Charges for Village Services**

**WHEREAS** Section 194 of the *Community Charter*, states that Council may, by bylaw, impose fees and charges for the provision of municipal services;

**AND WHEREAS** Council deems it necessary and desirable to exercise the authority provided by the *Community Charter* to cover costs of providing various services;

**NOW THEREFORE**, Council for the Corporation of the Village of Burns Lake, in open meeting assembled, **ENACTS AS FOLLOWS:**

**1. CITATION**

This Bylaw may be cited for all purposes as the "*Corporation of the Village of Burns Lake Fees and Charges Bylaw No. 1014, 2020*".

**2. PRESCRIBED FEES**
