Lakes District Arts Council – John and Sandra Barth

Burns Lake Mountain Bike Association – Patti Dube and Dave Sandsmark

- P. Dube and D. Sandsmark gave an overview of the history of BLMBA.
- BLMBA is seeking funding for an uptrack to the Boer Mountain trails.
- The uptrack would include the use of the Rod Reid Trail, which would join up to the Magee trail and bring riders to the bike park.
- Biking up the road is dangerous and it is more enjoyable to travel up on a trail.
- An uptrack is a great finishing piece for the facility and will enhance the tourism industry in the Lakes District.
- To have a trail to downtown is long term goal.

- P. Dube spoke about the UNBC Economic Benefit study.
- BLMBA is seeking a letter of support so they will have a letter ready to go for any grant opportunities that come up.
- D. Hill fully supports the uptrack and getting the bikes off of the main road, but he has heard concerns of combining walkers and bikers and wants to see signage.
- BLMBA will address having signage around the trail.
- The Mayor thanked the Burns Lake Mountain Bike Association for their presentation.

# Lakes Animal Friendship Society – Tracey Payne

- The Dog Park committee is making a lot of progress.
- It all began will the Lakes Economic Diversification Plan and N. Gerow's comment at the open house held at the mall.
- The Dick Schritt field next to the sani-dump was chosen as the best location.
- Proposing a 4 ft chain link fence.
- R. Dobbs has designed the dog park
- The committee has budget \$3,000 for landscaping and they will install an information kiosk for rules and to promote the area's tourism opportunities.
- Over the last 3 months the committee has been soliciting funds.
- The committee provided a letter for Council will a request for in-kind support from the Public Works crew and financial support for signage that aligns with the Village's Sign Strategy. Signage budget is stretched but they were hoping to install a nice wooden sign similar to the campground. However, the sign is considerably more money than budgeted.
