DELEGATIONS

Track Re-surfacing Committee – S. Barth and K. Saul

- S. Barth gave an update for the project.
- R.Hamp is the technical advisor for the project.
- The pavement resurfacing should last 20-25 years.
- The track is used year-round by the community and it is free to use.
- The track is owned by School District #91. It is estimated that the track is used 3% of the time by students.
- A rubber track, can't be plowed or salted/sanded, blacktop surface can be.
- The committee has raised \$30,000.
- Users range from children to seniors. The Initial Attack and Unit crews use it for training.
- Users are predominately women using the track, as it is perceived as a safe place to exercise.
- The track will become a more essential facility because it is FREE, no equipment, no volunteers or scheduling issues.
- Council asked what the subsurface is like, R. Hamp replied the four test holes were excellent. The material will be

- removed to have a proper slope so there is no pooling of water
- Council spoke about track teams at the high school, would installing asphalt inhibit a future track team. A rubberized track could be installed over top should a track team form.
- The \$194,000 project budget is for full width, SD #91 wants the full width resurfaced.
- The committee requested that Council match the funding they rececived and that it come from the ComFor Reserve account.

Rio Tinto – Lianne Olson, Advisor Communications and Communities

- Andrew Czornohalan Operations Manager, Rio Tinto
- The operational footprint is large, including 14,00 sq km of watershed.
- 1Kitimat Smelter 6 Billion dollars CAN investment
- Lowest CO emissions aluminum in the world is produced here.
- Partnerships are important to the company, changing the conversation to partner with communities and First Nations.
 Stewardship of the resource is broader than just one industry.
- \$225 million in salaries and benefits including retirees.
- 1.3 million in community grants, of that \$600,000 went to watershed communities.
- Nechako Reservoir Update
- Recreational and residential importance to Burns Lake
- Drought conditions in 2018, leading into lower than average snowpack, the reservoir is 4 feet lower than other years.
- They have reduced power generation at Kemano and have relied on BC Hydro to reduce the water requirement.
- Water Engagement Initiative
- Implemented Water Use planning based on the model used by BC Hydro.
- There have been 3 face-to-face meetings to date with community members.
- Open conversations regarding water, Rio Tinto is taking a more modern approach to water management.
- Climate change adaptation is this an anomaly or an ongoing change in climate?
- Rio Tinto is working with UNBC to bring together all research documents for climate change in northern BC.
- Rio Tinto is completing a socio-economic analysis and community social interest plan.
- Council discussed Tweedsmuir Park, and the drop in water levels this summer. Rio Tinto manages a point in the Nechako River/Stuart River to keep a 20 degree temperature. If there is a warm front coming they will

- release water to cool that area of the river, which drops the water levels upstream.
- Discussion of the water engagement initiative outcomes.
 Rio Tinto is at the table, also FLNRORD, endorsed by the water controller for BC, DFO, First Nations (Cheslatta very active participants) RDBN and District of Vanderhoof,
 Nechako Watershed Round table.
- The outcome is to better represent the interests of diverse interests. All of it is underpinned with technical people.
- Discussion of dredging of the reach, not considering at the moment, however, are looking at the long-term health of the reservoir.
